

LIMITED FIVE-YEAR MANUFACTURER'S WARRANTY

WHAT THIS WARRANTY COVERS. IDEATIVE warrants that the SOCKET SENSE™ will be free from defects in materials or workmanship under the terms and conditions of this limited warranty.

WHAT THIS WARRANTY DOES NOT COVER. This warranty does not cover:

- Any defects that are the result of misuse, abuse, or modification of the SOCKET SENSE™ or an act of God.
- Any defects that are the result of failure to follow the instructions included with the SOCKET SENSE™ or its use for other than its intended purposes.
- Any use of the SOCKET SENSE™ by anyone other than the first purchaser of the SOCKET SENSE™.

HOW LONG THIS WARRANTY LASTS. This warranty is for a period of five years from the date of purchase.

HOW TO MAKE A WARRANTY CLAIM. IDEATIVE's warranty is limited to repair or replacement of the SOCKET SENSE™. If your SOCKET SENSE™ is not operating properly or appears to have material or workmanship defects that are not the result of any of the exclusions listed above, please contact us at techsupport@ideativeinc.com, or call us at 877-484-4332 to receive approval and instructions for returning merchandise.

You are responsible for packing the SOCKET SENSE™ to avoid damage in transport, and for the expense of shipping. IDEATIVE will examine the SOCKET SENSE™ and, at its election, either repair or replace it. IDEATIVE will ship the repaired or replaced SOCKET SENSE™ to you at its expense.
